- b) The society may accept loan and advance from Government agencies/Banks/Corporation/Societies? Municipal Bodies/Boards, Institutions and other financial bodies and agents to undertake development projects and for such purpose as decided by the Governing body
- c) The funds of the society shall be kept in schedule/banks in the name of the society and the secretary shall operate the bank account of the society
- d) The financial year shall be from 1st April to 31st March each year
- e) The income and properties of the society shall be derived in whatever manner will be applied solely towards the maintenance, development and improvement of the society and for the promotion of its objects and ideas and no portion there of shall be paid for transferred by way of its profits to the members. This shall not preclude the society from paying any suitable remuneration or honorarium to members for any service.
- f) The Secretary/ Treasurer are empowered to Jointly or severally execute all necessary documents as prescribed by the bank/Financial for the purpose of raising loans

- 3. "Certified that the Association would not engage in agitational to ventilate to grievances"

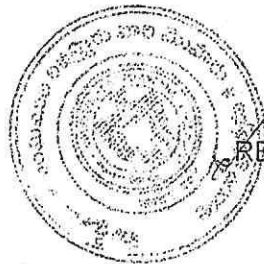

5. ADMISSION FEE AND THE ANNUAL SUBSCRIPTION OR MONTHLY SUBSCRIPTION

NO ADMISSION FEE

ANNUAL SUBSCRIPTION RS.100

6. GENERAL BODY :

(i) Annual General Body will meet once in a year i.e., in the month of JUNE

(ii) FUNCTIONS :

- a) To pass the budget for the ensuing year and approve expenditure statement of previous year.
- b) To approve the reports of the activities of Society.
- c) To elect the Executive Committee etc.
- d) To appoint Auditor.

Executive committee : shall consist of FIVE (5) Members and out of them, the following office bearers shall be elected by the E.C. Viz., President, General Secretary, Joint Secretary and Treasurer and the remaining persons all the Executive Committee Members.

ii) The members of the Executive Committee (Governing Body) shall be duty bound to attest the signatures of all the members of newly elected Executive Committee and to see that the said signatures of the outgoing Governing Body tally with the annual list as filed with the Register of Societies before 15 days the succeeding month in which elections were held.



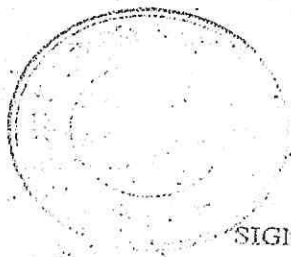

FUNCTIONS OF THE EXECUTIVE BODY AND OFFICE BEARERS :

1. **PRESIDENT** : He presides over all the meeting of the both General Body and Executive Committee, he can cast his vote in case of tie. He can supervise all the branches of the society.
2. **VICE PRESIDENT** : He shall assist the president in discharging his duties in the absence of the President he shall perform the duty of the president as entrusted by him.
3. **SECRETARY** : He is the their Executive Officer of the society and custodian to all records relating to the society and correspondent on behalf of the society. He has to take on records of all minutes of the society to conveyed both the bodies of the society with the permission of the President. He guide the treasurer in preparing the budget and expenditure statement of the society.
4. **JOINT SECRETARY** : He has to do the work entrusted by the executive committee. He has to assist the Secretary in discharging his duties, in the absence of the secretary, he can perform the duties of the Secretary.
5. **TREASURER** : He is responsible for all financial transactions and funds of the society. He has to maintain accounts properly along with the vouchers he has to prepare the accounts of the society jointly with the secretary or president.
6. **OFFICE BEARERS** : They are the responsible person to attend to such activities of the Societies which the Executive Committee entrust to them.
7. **QUORUM** : Half of the total members for General Body Meeting and 1/4 for Executive Committee Meeting.
8. **FUNDS** : The Funds shall be spent only for the attachment of the objects of the society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any means.
9. **AMENDMENTS** : No amendment or alteration shall be made in the purpose of the association unless it is voted by 2/3 of its members present at a special meeting conveyed for the purpose and confirmed by 2/3 of the members present at a second special meeting.
10. **WINDING UP** : In case the society has to be wound up the property and funds of the society that remain after discharging the liabilities, if any, shall be transferred or paid to some other institution with similar aims and objects.
